<b>Pharmacy</b> <ul style="list-style-type: none"> <li>• <b>Express Scripts</b></li> </ul>	Express Scripts is dedicated to providing access to affordable medications and services to help you stay healthy. <b>No additional cost to employees.</b>
<b>Dental</b> <ul style="list-style-type: none"> <li>• <b>Aetna</b></li> </ul>	Stay on top of your oral health with dental benefits from Aetna. Aetna Dental offers service and support for your dental needs with preventive care like oral examinations and cleanings twice per calendar year covered at 100% when using an in-network dentist. <b>No additional cost to employees.</b>

<b>Flexible Spending Accounts</b> <ul style="list-style-type: none"> <li>• Health Care</li> <li>• Dependent Care</li> <li>• Transit and/or Parking</li> </ul>	IRS limits apply to all four Flexible Spending Accounts. Healthcare FSA offers carryover up to \$640 into the following year and employees have additional 2 ½ month grace period to file claims in the following year.
<b>Retirement Savings Plans</b> <ul style="list-style-type: none"> <li>• 401(k)</li> <li>• 457 Def Compensation</li> </ul>	Employees can enroll in both plans up to IRS Annual Limits. Pre-Tax and Post-Tax options offered by both plans. 401(k) through Empower Retirement. 457 through MissionSquare.
<b>Railroad Retirement Board Pension</b>	RRB vesting is 60 credited months of service.
<b>Vacation, PTO, and Holidays</b>	Vacation up to maximum of 25 days based upon years of service. Personal, Sick days and up to 12 Holidays per calendar year (varies by collective bargaining agreement).
<b>Public Student Loan Forgiveness</b>	Full-time employees at a government agency may be eligible to participate.
<b>Work Life Balance</b>	Work locations are in Chicago and surrounding suburbs.
<b>Employee Recognition</b>	Service Awards and Gifts, My Metra, and Retirement Gifts.
<b>Employee Discounts</b>	Perks at Work Discount Program
